1. INTRODUCTION

The second Multiplier Event (ME2) – *Skills cards for new professional roles: easy-to-read validators and facilitators* – of the TRAIN2VALIDATE project was organized face-to-face, on October 28, 2021, by Plena Inclusión Madrid. The venue was the conference room of Ceapat (Spanish Centre for Accessibility and Technical Supports), which is associated partner of the project.

Table 1 presents the identification data of the event. Some of the topics are detailed in the next sections.

2. AIM

The main aim of the event was to disseminate the skills cards of easy-to-read validators and facilitators and how the project partners developed the process to obtain them. Additionally, the event had the purpose of disseminating the importance of those roles in the easy-to-read production process and other concepts related to them, as standardisation, professionalisation and real experiences to share. The program of the event is detailed in Section 3 and presented in Annex 1.

3. DISSEMINATION

The ME2 dissemination strategy consisted in advertising the event on a multitude of channels, including the project's website, the T2V mailing list, social and professional networks (Facebook,

Twitter, and LinkedIn), and in a series of press releases from the partners' institutions. Moreover, the project was advertised on the personal networks of the project members.

A significant aspect of the dissemination strategy was to inform the participants that the event was face-to-face with safety measures in a well-known venue in Spain linked to accessibility, that attendance was free and that certificates of participation would be offered to all participants.

The languages of dissemination were the ones of the project partners and English. A selection of the dissemination examples is presented below:

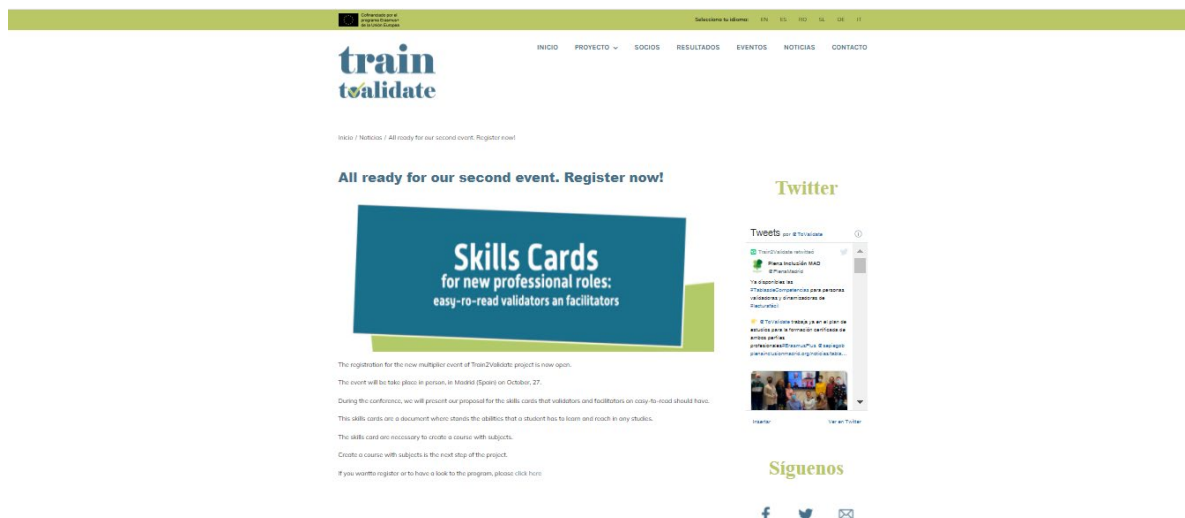


Figure 1. News about the opening of the registration for the event

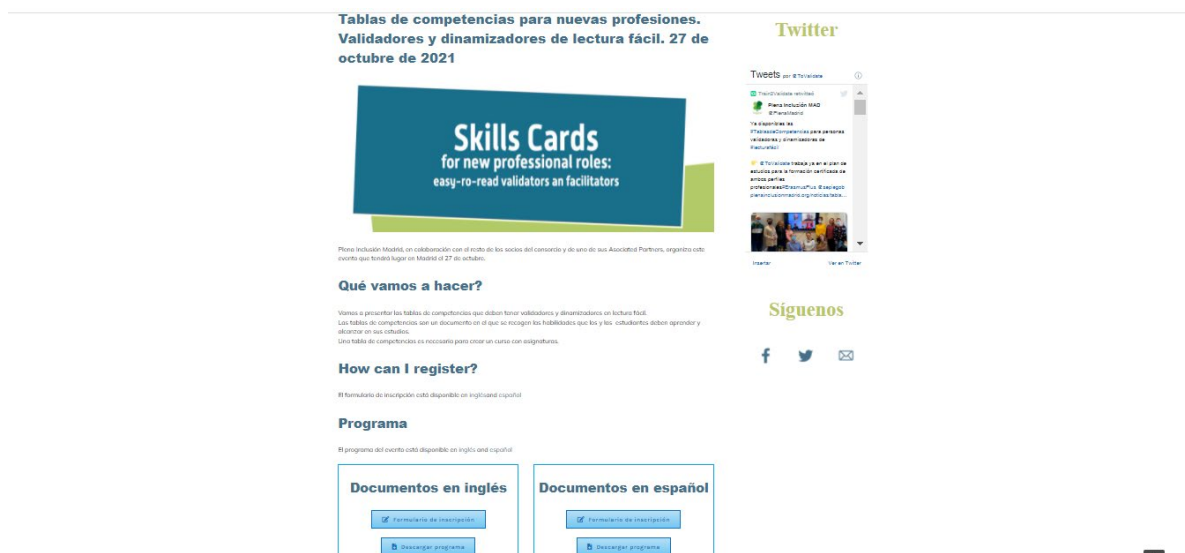


Figure 2. Section of the website dedicated to the dissemination of the event

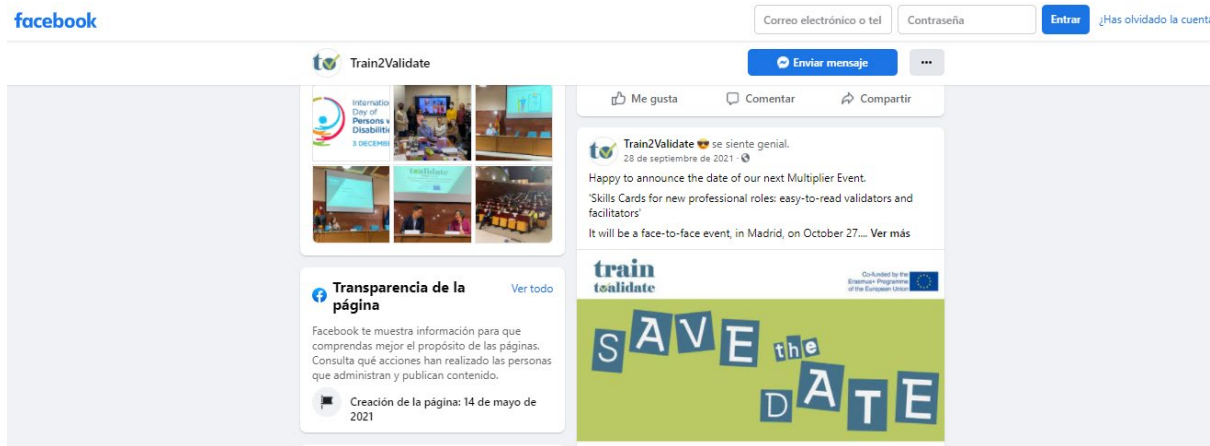


Figure 3. News in Facebook

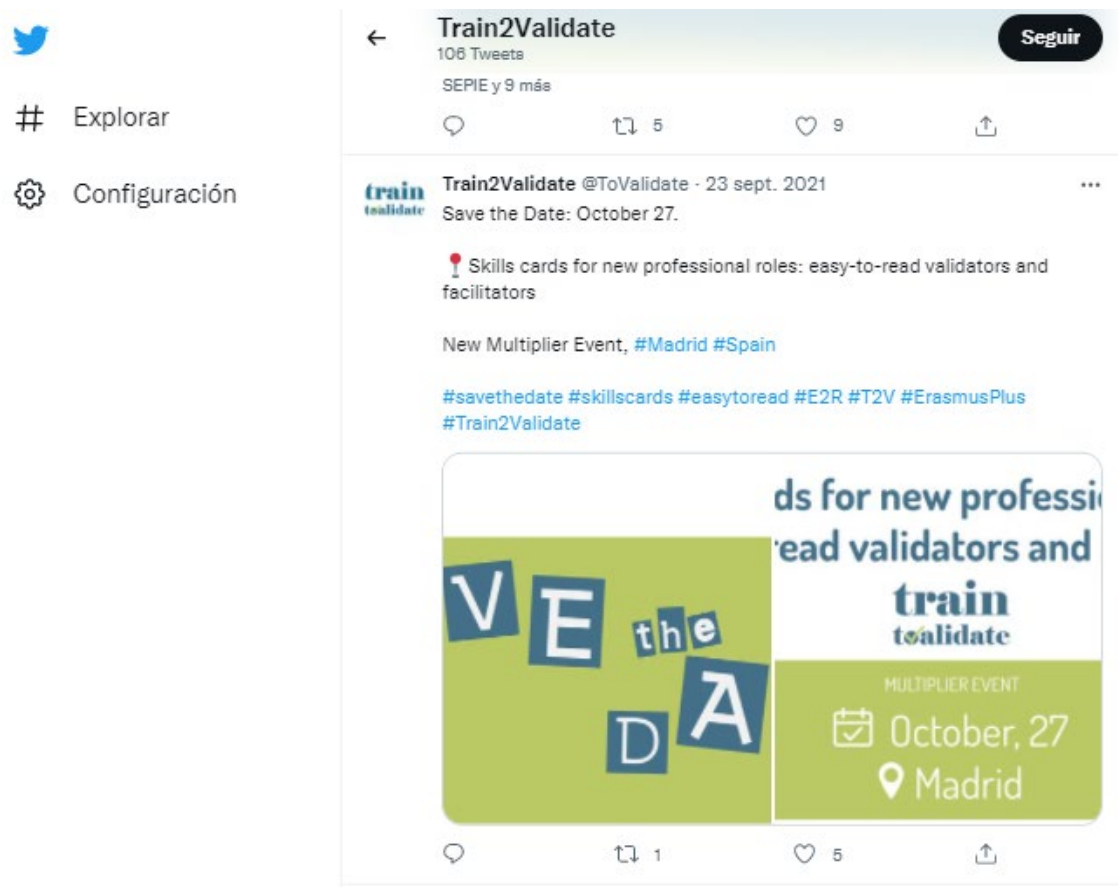


Figure 4. News in Twitter

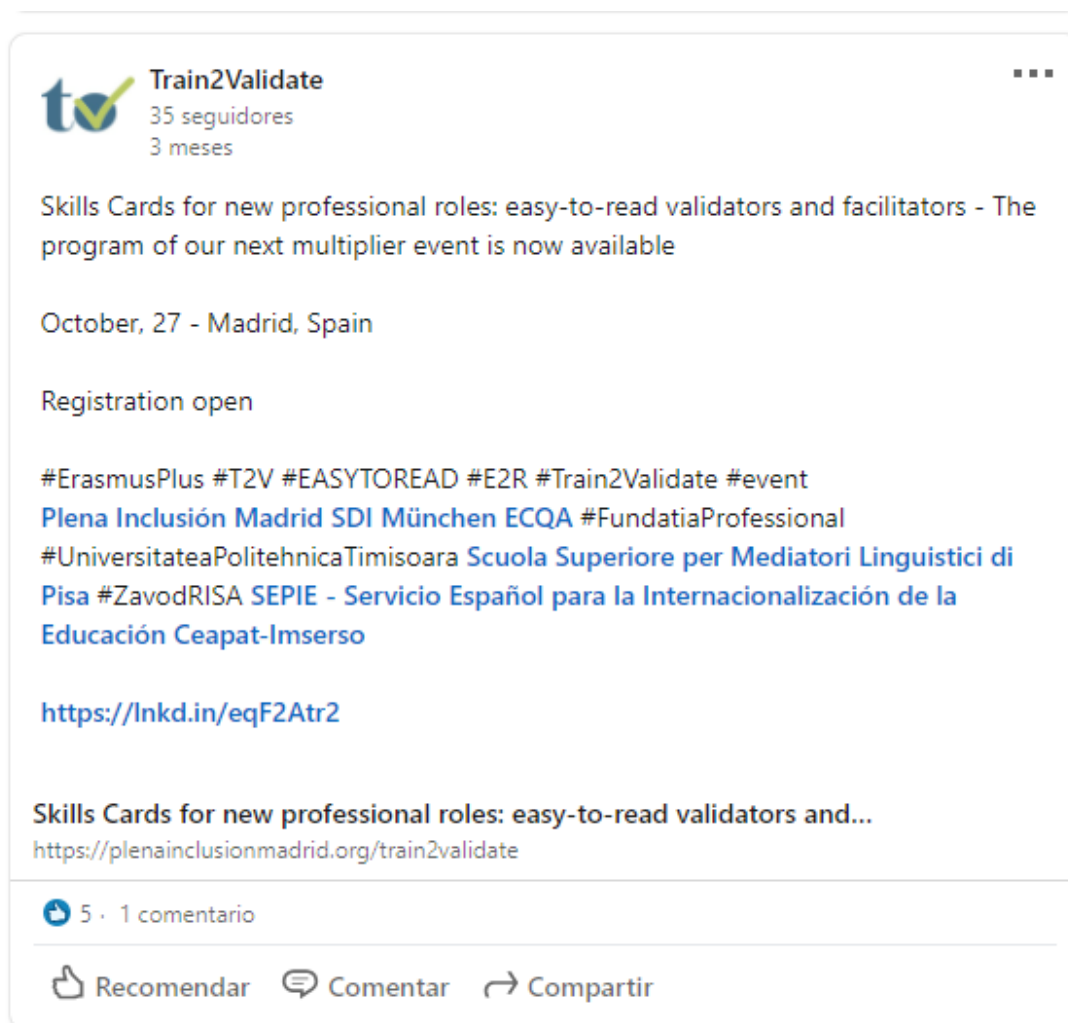


Figure 5. News in LinkedIn

4. DESCRIPTION OF THE EVENT

The event was organized face-to-face on May 28, 2021. The one-day program included a morning and an afternoon session, presented in detail in what follows.

The event was opened by official addresses given by Mrs. Tatiana Aleman, Managing Director of CEAPAT, and Mr. Javier Luengo, General Manager of Plena Inclusión Madrid. They stressed the importance of easy-to-read as inclusive tool for readers with comprehension difficulties and the opportunity that a professionalisation of validation means for people with intellectual disabilities.

Óscar García Muñoz, the project leader opened the morning session with an overall presentation of the TRAIN2VALIDATE project. He also explained the ways in which the audience could interact in the event: short live surveys with the online tool Menti, speakers corner and open questions to panellists.

The morning session of the event was divided in two parts. The first part was titled ‘Steps for new professions: validators and facilitators’ and consisted in a talk to explain how the project partners have built the skills cards for easy-to-read facilitators and validators and a panel with real facilitators and validators.

In the interactions with Menti, Patricia Hortal posed 3 questions. The first one was about the profession of the audience, with the following results:

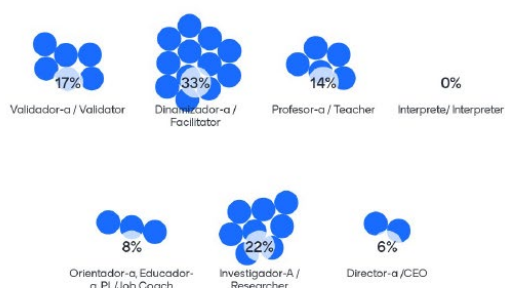


Figure 9. Menti: what is your profession?

Patricia Hortal asked also about the competences that the audience considered most quoted competences. From the 28 total answers, 18 mentioned “easy-to-read guidelines”, 8 “teamwork skills” and 2 “computer skills”. Finally, she asked if the audience considered that the project will achieve the goal of developing the skills cards and the training. All answers (42) were positive.

After this presentation, the following panel was made up of two facilitators (Beatriz Pindado, from the association Adisli and María José Sánchez, from the association AM Pinto) and two validators (Laura Díaz, from the association Adisli and Fernando Plaza, from the association AM Pinto). They were moderated by Elena González, from Plena Inclusión Madrid.

In the panel, the participants explained the tasks of their work, their regular organisation for the working sessions and the main difficulties. In the Menti questions with the audience, people was requested about their link with easy-to-read. Most of them have worked in any role related to easy-to-read:

The audience was also asked about needed supports to publish more easy-to-read texts. The most mentioned was public administrations, followed by publishing house and associations.

The morning session continues after the coffee break with the second part titled 'Building new professions in accessibility'. It was made up of two panels. In the first one, four of the project partners (Simona Simon, Polytechnic University of Timisoara; Angela Cotoara, Fundatia Professional; Francesca Blevé, Scuola Superiori per Mediatori Linguistici Pisa, Tatjana Knapp, Zavod RISA) moderated by Patricia Hortal. They commented about the steps that the project had done since the beginning with the initial survey and the creation of these skills cards, the importance of easy-to-read for inclusion of different people with reading difficulties and the steps that the project has to go forward.

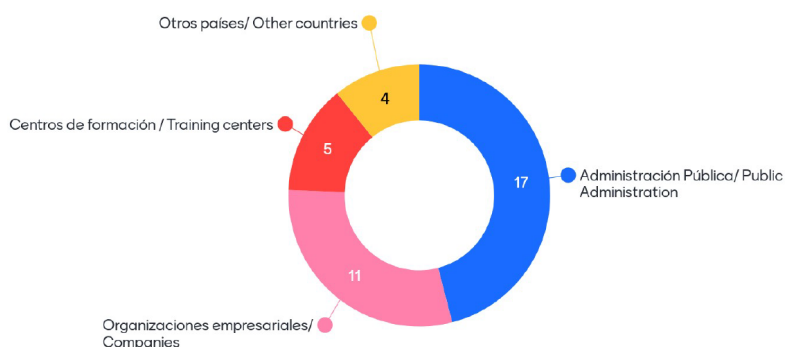


Figure 12. What have we learnt? What are the next steps? Building E2R professions

In the second panel, the participation was divided in a recorded interview to Antonio Prieto, independent expert specialised in the development of training programmes, that shares the challenges to develop the easy-to-read skills cards for a real professionalisation. After that, Delfín Jiménez, vicepresident of the Spanish Association of Accessibility Professionals (Asepau, in its initials in Spanish), and Gabriele Sauberer, vicepresident of the European Certification and Qualification Association (ECQA), moderated by Rocío Bernabé (SDI Munich), discussed about the need of an organised and certified professionalisation of easy-to-read aligned with the development in other accessibility fields, as building or web.



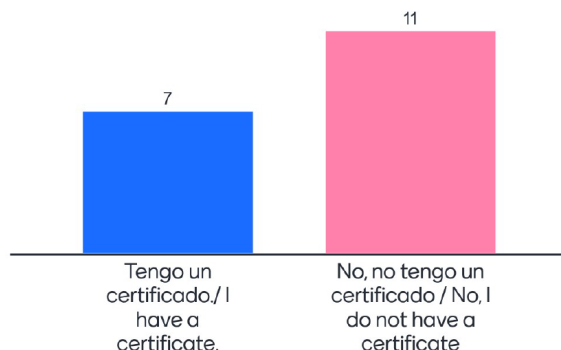
Figure 14. Is it possible to create inclusive professions in accessibility?

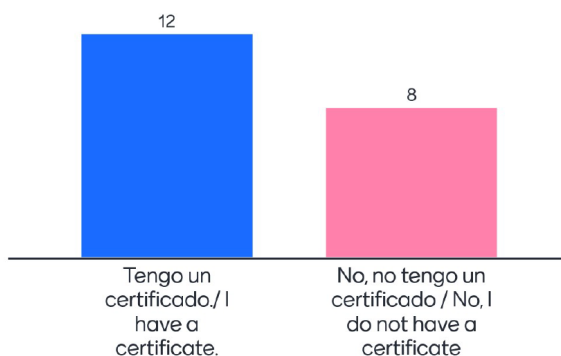

After the lunch, it took place the third part of the event in the afternoon session, titled 'Standards and E2R services'. The first panel discussed the choices for standardisation of easy-to-read, taking in to account the published standard of easy-to-read in Spain and the standard in progress in Germany. One of the panellists, Mónica Rodríguez, from Fundación ONCE and vicepresident of the task group for the Spanish easy-to-read standard, recorded a video with her comments. In the conference hall, Clara Delgado, from Ceapat and president of the task group for the Spanish easy-to-read standard,

and Rocío Bernabé, from SDI Munich and member of the task group for the German easy-to-read standard, moderated by Óscar García Muñoz, from Plena Inclusión Madrid, about the difficulties of including validation in these standards and the discussion among the task group members.



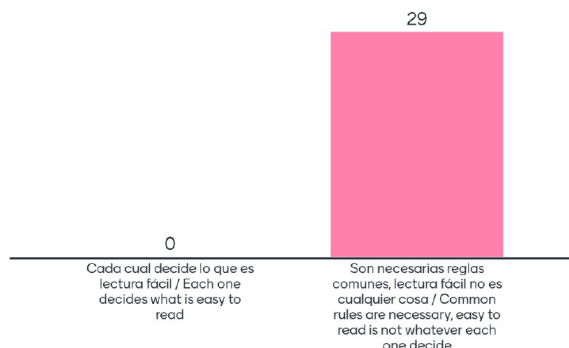
Figure 17. Easy-to-read standards and validation. Is it possible?

The last panel of the event was about easy-to-read real experiences. Four initiatives were selected: Tatjana Knapp, Zavod RISA, Slovenia; Antonio Hinojosa, Plena Inclusión España; Polín Olguín, CEDETi, Chile; and Anabel González, Cognitive Accessibility Office Extremadura, Spain. In the case of Polín Olguín and Anabel González, the participation was online through Zoom. All of them, moderated by Carlos Sánchez, from Grupo Amás and member of the Train2Validate advisory board, presented their experiences and the role of validators and facilitators in them.

The audience participated actively during the event, not only with Menti, but also with questions for the panellists. The speakers corner did not attract any person from the public, as they preferred to participate from their own seats.

All available presentations from speakers are available in annex 3 of the report.

5. PARTICIPATION AND IMPACT

Two registration forms were opened (Spanish and English). 70 persons from 4 countries registered in the Spanish form (20 facilitators and 19 validators) and 17 (4 validators) from 6 countries registered in the English form. Finally, 56 persons from 4 countries (52 Spain, 2 Chile, 1 Brazil and 1 Hungary) attended the event. Additionally, 2 panellists participated online through Zoom and 2 other panellists with recorded videos. The number of the actual participants does not include the attendees from the project partners' institutions or organizations.

All participants and speakers received a paperback certificate of attendance and by mail the ones who participated online.

The impact and visibility of the event were also insured by a series of actions posting and commenting in real time on social platforms (Facebook and Twitter). Additionally, all participants received a leaflet about the project and a certificate of attendance.

6. ACCESSIBILITY OF THE EVENT

In order to follow the accessibility protocol of the project for multiplier events, we accomplished the following accessibility tasks:

- Venue: celebration in the building of Ceapat, which has a certification of accessibility of the building and its facilities (UNE 170.001-2)
 - > parking lots for people with disability: yes
 - > accessible entrances/exits to the building and rooms: yes
 - > elevator (or ground floor): yes
 - > support staff: yes, staff from Plena Inclusión Madrid
 - > E2R orientation signs: yes, provided by the venue
- Session

- Posting and commenting live on social platforms during the event.

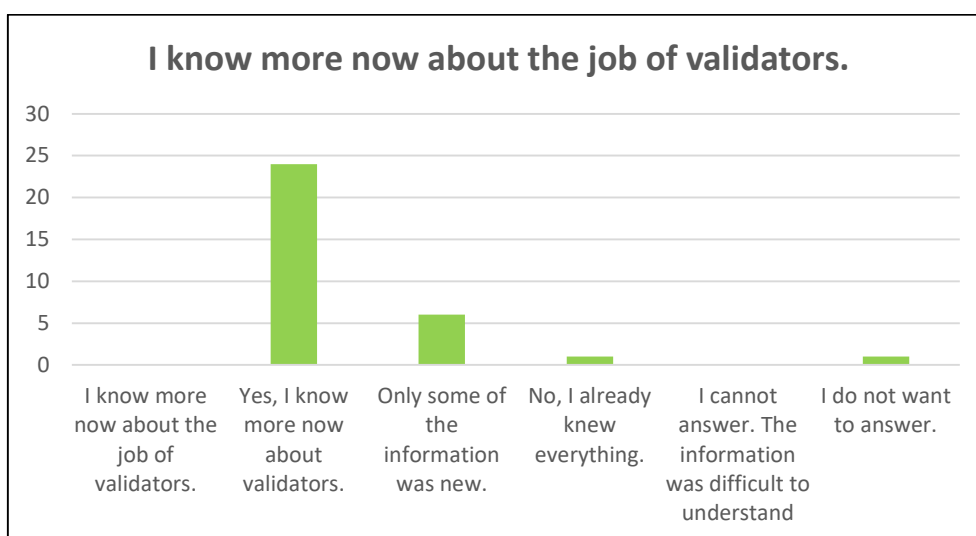
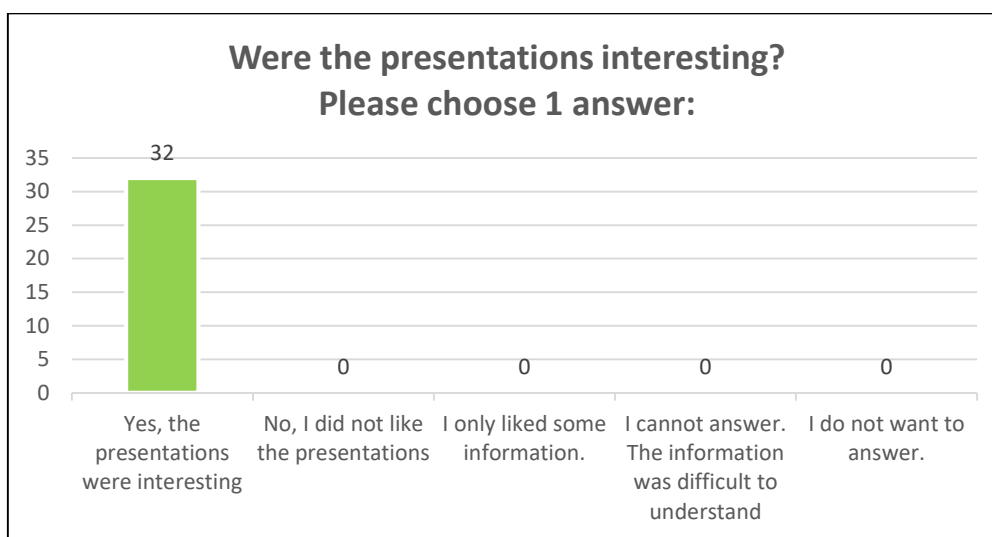
As the event was celebrated under the restrictions due to the Covid pandemic, certain measures for general health security were adopted:

- Availability of hygienic gel
- Compulsory use of face mask
- A seat of separation between to attendants
- Regular microphone cleaning
- One way circulation inside the building to avoid people crossing coming in and going out.

- Information with rules and recommendations for all attendants.
- Separation in groups for coffee break and catering and celebration of both in an open-air space.

7. SATISFACTION SURVEY

The satisfaction survey was drafted and disseminated by the Quality Manager, who also collected the answers. The survey consisted of 5 multiple-choice questions and of an open question, where participants could add their comments, and was filled out by 32 persons. The survey is presented in Annex 2. The overall feedback was extremely positive, as it follows:



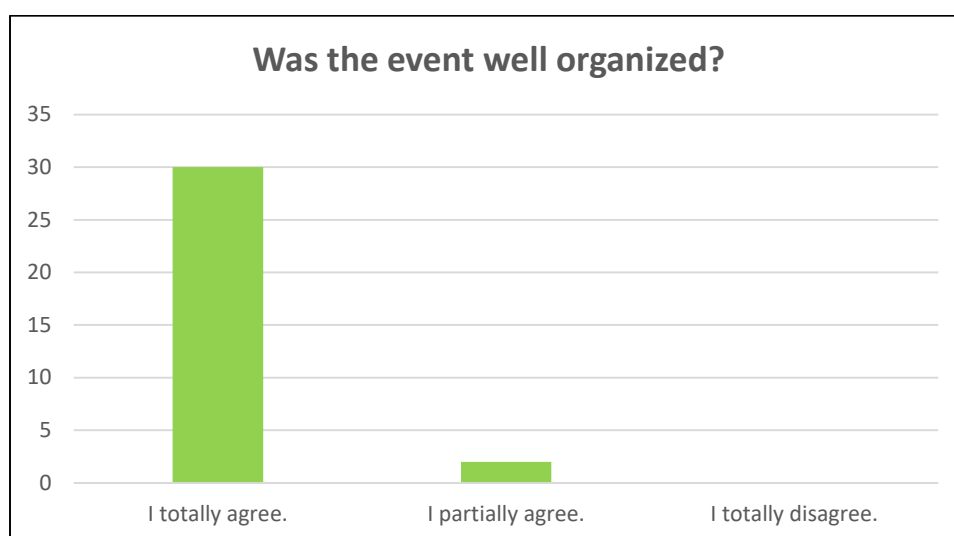
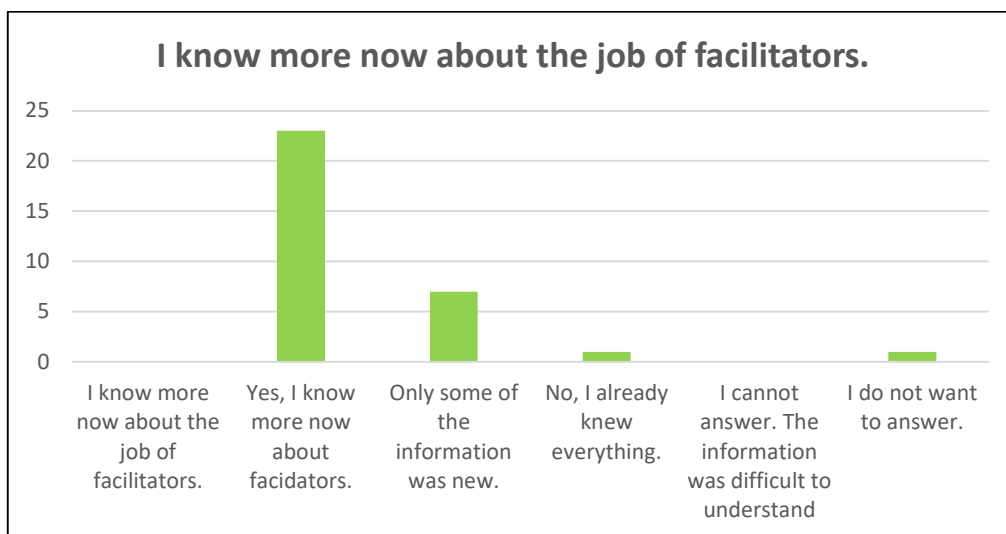


Figure 22. Charts with the results of the satisfaction survey of the event
